

# PANORAMA STALLION SERVICE CONTRACT



I, \_\_\_\_\_, owner of the stallion, \_\_\_\_\_ agree to donate one (1) breed to the Panorama Horse Show Circuit (PHSC) Stallion Service Auction. I agree to do everything possible to get the mare in foal and guarantee a live foal or one return breed. A live foal is described as a newborn foal that stands and nurses. I also agree to provide the mare owner with the appropriate breeders certificate. The mare will not be bred until I have received notification from PHSC that the service has been paid in full. I understand that I will receive one (1) free nomination to the PHSC Weanling Halter Futurity next year and my stallion and his "get", will be eligible to participate in all qualifying futurity classes for the next 6 (Six) years. If the breed to my stallion is not sold during the auction for a minimum of one half (1/2) of the stallion's fee, the service may be sold by the PHSC before August 1 of this year. **I understand that I have the option to purchase the service for a minimum of one half (1/2) of the stallion's fee in order to nominate my stallion into eligibility for the futurity (owner nominated).**

Please contact PHSC before breeding if you have not received a notification.** All guarantees are between the stallion and mare owners and will not involve PHSC. The Auction is for a **breed fee only**. Additional charges such as mare care, shipping fees, vet fees, chute fees, collection fee's, etc., are the responsibility of the mare owner. All sales are final, No refunds.
